 - Proper notice must be given to the City of Forest before entering into the Wastewater Treatment Plant.

 - The City of Forest will not pay the mobilization fee and set-up by contractor, since they will already be in surrounding area.
 - Price of project will be determined by the gallons of sludge removed.
 - City of Forest will negotiate with contractor the minimum amount of sludge to be removed.
